

DETROIT LIONS HOME GAME SWEEPSTAKES

NO PURCHASE OR PAYMENT OF ANY KIND REQUIRED TO WIN

1. Eligibility: Detroit Lions Home Game Sweepstakes (the "Promotion") is open only to United States residents who are eighteen (18) years of age or older (except in the case of certain residents of states in which the legal age of majority is twenty-one (21), such legal age of majority) at the time of entry and who have downloaded the free Detroit Lions Mobile application ("the App") on his/her mobile device. Employees, officers, partners, and directors (including immediate family members (spouse, parent, child, sibling and their respective spouses, regardless of where they reside) and members of the same household, whether or not related) of Sponsor (defined below), its affiliated companies and subsidiaries and advertising and promotion agencies are not eligible to participate or win the Prize (defined below). Each eligible person who submits an entry is referred to herein as an "Entrant". The Promotion is subject to all applicable federal, state and local laws and regulations and is void where prohibited. Participation constitutes Entrant's full and unconditional agreement to these Official Rules and Sponsor's decisions, which are final and binding in all matters related to the Promotion. Winning a prize is contingent upon fulfilling all requirements set forth herein. The Promotion is a sweepstakes (the "Sweepstakes").

2. Sponsor: The "Sponsor" is The Detroit Lions, Inc., 222 Republic Drive, Allen Park, MI 48101.

3. Timing: The Promotion begins on August 7, 2019 at midnight Eastern Time ("ET"), ends on December 29, 2019 at 11:59 p.m. ET (the "Promotion Period"). During the Promotion Period, there will be seven home game (7) drawings; one after each Detroit Lions 2019 season home game during the Promotion Period (each a "Home Game Drawing") and one (1) grand prize drawing ("Grand Prize Drawing") (collectively the "Drawings").

4. How to Enter:

Home Game Drawings: There are two methods of entry for each Home Game Drawing, each unlimited:

Spend Entries. During the Promotional Period, for each purchase of food, beverages or merchandise made at a Ford Field concession or retail location in which a Lions Perks member ("Member") scans his/her Lions Perks card from the Detroit Lions Mobile App, the Member will receive one bonus entry into the Sweepstakes ("Spend Entries") for each whole dollar spent during the Promotional Period. If a Member's total Spend Entries are not a whole number, the total will be rounded down to the next whole number. Purchases may be made at a Detroit Lions game or during Ford Field's regular concession and retail store business hours on non-gamedays. Purchases of food and beverages catered to suites or private events, game tickets, parking, and 50/50 raffle tickets are not eligible for Bonus Entries.

Mail Entries. Alternatively, you may mail a 3x5 postcard in an envelope with Entrant's name, address, email address, and telephone number to The Detroit Lions, Inc., 2000 Brush St., Ste. 200, Detroit, MI 48226 Attention: Detroit Lions Home Game Sweepstakes (each, a "Mailed Entry"). Each 3x5 envelope received will constitute one entry. If more than one 3x5 cards are included in an envelope, only the first shall qualify. All Mailed Entries must be received by 5 p.m. ET the Friday before the Detroit Lions home game in which the Home Game Drawing will take place. Mailed Entries received after Friday at 5 p.m. ET will be automatically entered into the next Home Game Drawing. The final cut-off date for Mailed Entries is Friday at 5 p.m. ET prior to the last Home Game Drawing (December 27, 2019).

Grand Prize Drawing: All Spend Entries and Mailed Entries received during the Promotional Period will automatically be entered into the Grand Prize Drawing. There is no separate method of entry for the Grand Prize Drawing.

5. Prize: Sweepstakes Prizes:

Home Game Drawing Prizes: SEVEN (7) separate prizes consisting of ONE (1) of the following: ONE (1) \$500 Kroger gift card; FIVE (5) \$100 Kroger gift cards; and ONE (1) autographed piece of Lions merchandise to be chosen by Sponsor (each a "Home Game Prize"). Home Game Prizes will be awarded from the above in the order drawn.

Grand Prize: ONE (1) winner will receive ONE (1) \$1,000 Kroger gift card and ONE (1) autographed piece of Lions merchandise to be chosen by Sponsor ("Grand Prize").

A Home Game Prize and Grand Prize shall be individually referred to as a "Prize" and collectively be referred to as "Prizes." Odds of winning Prizes will depend on the number of eligible entries received during each Home Game Drawing period and during the Promotional Period. Limit of one prize per winner per drawing date. No cash equivalent may be elected and the Prizes are non-transferable. Prizes may not be substituted for any other prize, except that Sponsor reserves the right to substitute a Prize for one of equal or greater value if the Prize should become unavailable for any reason. Winners are solely responsible for all federal, state, and local taxes and fees associated with Prize receipt and/or use. Winner, if an individual, must provide Form W-9 and provide social security number for issuance of Form 1099-MISC. Home Game Drawing: Within seventy-two hours (72) of the end of a home game, seven (7) Home Game Prize winners will be selected at random from all Spend Entries and Mailed Entries received for that Home Game Drawing, such that each and every entry shall have the same odds of winning.

Grand Prize Drawing: On January 3, 2020 at 3:00 p.m. ET, a Grand Prize winner will be selected at random from all Spend Entries and Mailed Entries received during the Promotional Period, such that each and every entry shall have the same odds of winning.

All potential Prize winners are subject to verification before a Prize will be awarded and receiving the Prize is contingent upon compliance with these Official Rules. The potential Sweepstakes winners will be promptly notified by the email or phone number provided upon entry or as listed in the Lions Perks account. Sponsor is not responsible for changes in either. Where allowed by law, the Prize winners will be required to sign and return a Declaration of Compliance, Liability and Publicity Release which must be received by the Sponsor within seven (7) days of the date notice or attempted notice is sent, in order to claim the Prize. If a potential winner of the Prize cannot be contacted, fails to respond to the notification or fails to sign and return the Declaration of Compliance, Liability and Publicity Release or provide any other requested information within the required time period (if applicable) the potential winner forfeits the Prize. In the event that a potential winner of the Prize is disqualified for any reason, Sponsor will award the Prize to an alternate winner by random drawing from among all remaining eligible entries until all Prizes are awarded.

ALL POTENTIAL WINNERS ARE SUBJECT TO VERIFICATION BY SPONSOR, WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE PROMOTION. Prizes may not be redeemed for the purchase of alcoholic beverages.

DETROIT LIONS SUPER BOWL LIV AND 2020 NFL PRO BOWL SWEEPSTAKES OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND NECESSARY

1. Eligibility: Detroit Lions Super Bowl LIV and 2020 NFL Pro Bowl Sweepstakes (the "Promotion") is open only to United States legal residents who are eighteen (18) years of age or older (except in the case of certain residents of states in which the legal age of majority is twenty-one (21), such legal age of majority) at the time of entry and who are Detroit Lions Season Ticket Members ("STM") whose account is in good standing on the date the Promotion Period (defined below) begins, and who have the Detroit Lions Application. Ticket brokers, as determined in the sole discretion of Sponsor, are excluded. Employees, officers, partners, and directors (including immediate family members (spouse, parent, child, sibling and their respective spouses, regardless of where they reside) and members of the same household, whether or not related) of Sponsor (defined below), its affiliated companies and subsidiaries and advertising and promotion agencies are not eligible to participate or win a Prize (defined below). Each eligible STM who receives an Automatic or Bonus Entry (defined below) is referred to herein as an "Entrant". The Promotion is subject to all applicable federal, state and local laws and regulations and is void where prohibited. Participation constitutes Entrant's full and unconditional agreement to these Official Rules and Sponsor's decisions, which are final and binding in all matters related to the Promotion. Winning a prize is contingent upon fulfilling all requirements set forth herein. The Promotion is a sweepstakes (the "Sweepstakes").

2. Sponsor: The "Sponsor" is The Detroit Lions, Inc., 222 Republic Drive, Allen Park, MI 48101.

Bonus Entries: During the Promotion Period applicable to each separate Prize, for each purchase of food, beverages or merchandise made at a Ford Field concession or retail location in which a STM scans his/her Lions Perks card from the Detroit Lions Mobile App, the STM will receive one bonus entry into the Sweepstakes ("Bonus Entries") for each whole dollar spent during such Promotion Period. If an STM's total Bonus Entries are not a whole number at the end of the Promotion Period, the total will be rounded down to the next whole number. Purchases may be made at a Detroit Lions game or during Ford Field's regular concession and retail store business hours on non-gamedays. Purchases of food and beverages catered to suites or private events, game tickets, parking, and 50/50 raffle tickets are not eligible for Bonus Entries. Each Entrant's Automatic Entries and Bonus Entries received during Second Prize Promotion Period will remain eligible for the Grand Prize in addition to any Bonus Entries received during the balance of the Grand Prize Promotion Period.

6. Verification of Potential Winners: On the Drawing Date following each Promotion Period, a Prize winner will be selected at random from all Automatic Entries and Bonus Entries such that each and every entry shall have the same odds of winning. Sponsor is not responsible for the failure of either Super Bowl LIV or the NFL Pro Bowl games to be played, or acts or circumstances beyond its control, including weather, travel restrictions or other unforeseen circumstances. Travel times, seat locations, and hotel/room selection are in the sole discretion of Sponsor.
